## RESOLUTION -4

### KASHMIR PROBLEM

Jammu and Kashmir has been disturbed state ever since India became independent in 1947. Pakistan attacked India in 1947, 1965, 1971 without any provocation, which was repulsed by India forces. Again it tried to take over Kargil and few other areas around it, but again it was defeated. Few policy decisions by the then Indian government compounded the problem further. First it was the declaration of ceasefire at a time, when we were about to take over the area occupied by Pakistan. That area known as POK is still under the illegal occupation of Pakistan.

Second mistake was reference to U N for intervention. Now of course U N will not intervene in the dispute, as it is a bilateral issue. The third blunder by the then Prime Minister Nehru was committed by constituting Article 370, which was discriminatory and unwarranted, since the accession of J&K state with India had already been done.

Separatist elements in J&K in 1989 displaced Kashmiri pundits and committed rape, arson and loot. This was done to win over during plebiscite, because Muslims will be in majority. Now there is no question of referendum. They have been attacking Army and other defence establishments. Assisted by Pakistan, they have been recruiting youth, getting them trained in Pakistan and deploying them in suicidal attacks on various establishments. Successive governments of J&K have been openly supporting the separatist elements. Government is spending hundreds of crore in providing them security and comfort in hotels. The recent statement by Former Chief Minister of J&K Mehbooba Mufti is most shocking and unbecoming of a former C M, when she says that this will produce Hindu Taliban. This word was again used by a learned advocate Rajiv Dhavan in Supreme court during the hearing of Babri Masjid vs Ram Mandir case. These elements are out to disintegrate India. There is an

urgent need to take action against such anti national. There could not be a bigger travesty of justice when an FIR is filed against defence personnel in discharge of their duty and

protecting themselves against the stone pelters. It has become a routine by these hooligans, who obstruct security forces in flushing out Terrorists from their hide outs by pelting stones. Advocates of human rights, instead of blaming the stone pelters, criticised the army and accused them of atrocities. The opposition parties have lost their conscience and are supporting the separatists, who are engaged in anti national activities.

Forum For Awareness of National Security after debating the issue has resolved That;

1. Severe punishment be meted out to the separatist elements.
2. Organisations, which are engaged in antinational activities, be banned.
3. Every individual has right to protect himself and so are the army personnel. Anybody pelting stone or harming the defence establishments must be punished. Army should be given free hand during in dealing with anti national elements.
4. Article 370 be abrogated since J&K is an integral part of India. There cannot be two constitutions in a country. The process can start with deleting Art 35A. Earlier it is done, better it is.
5. Army should be allowed to cross the border in hot pursuit.
6. The land occupied by Pakistan like POK should be taken back diplomatically and if necessary by force.
7. Action must be taken against those persons and parties who glorify and support the separatists.
8. Security to separatists must be withdrawn without further delay. .They must be treated like anti national and lodged in Jail
9. Those persons, who decided to migrate to India from Pakistan in 1947 must be given citizenship. They are deprived of benefits enjoyed by other citizens even after more than 70 years.
